As per the Notification No. 8/2017-Integrated Tax (Rate) dt. 28th June, 2017 of Department of Revenue, Ministry of Finance, Govt. of India, it is notified that the integrated tax, on the inter-State supply of services of description as specified in column (4) of the Table below, falling under Chapter, Section, Heading & Group of scheme of classification of services as specified in column(2) & GST Service Accounting Code(SAC) in column(3), shall be levied w.e.f. 1st July, 2017 at the rate as specified in the corresponding entry in column(5) of the said Table:
